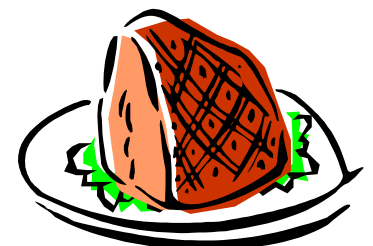
On Jan. 9th at 11:30 to 1:00 there will be a luncheon sponsored by the Rec Committee. All are welcome to attend.

Shirley O'Neal is at home and using a walker and is recovering.

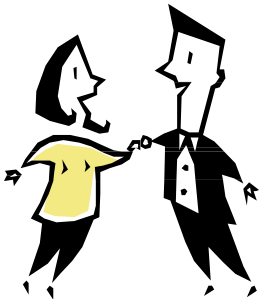
Marge Cook wishes to thank everyone for their cards and best wishes. Marge does not think they will make it this winter.
